# "Mastercard Gra z WOŚP 2024" Event Terms and Conditions

(hereinafter the "Terms and Conditions")

#### 1 Definitions and General Provisions

- The Event shall be held on terms and under conditions laid down in the present Terms and Conditions of the "Mastercard Gra z WOŚP 2024" event (hereinafter the "Event"). The Event's purpose is to support the statutory activity of the Beneficiary as part of the 32nd Grand Finale of the Great Orchestra of Christmas Charity (WOŚP).
- 2. The Event's Organizer is Mastercard Europe spółka akcyjna oddział w Polsce with its registered office in Warsaw at plac Europejski 1, 00-844 Warszawa, entered into the register of entrepreneurs of the National Court Register (KRS), kept by the District Court for the Capital City of Warsaw in Warsaw, 13th Commercial Division of the National Court Register, under the KRS number: 0000345959, NIP (Tax Identification Number): 1070015237, REGON (Statistical Identification Number): 142191116 (hereinafter the "Organizer").
- 3. The Event's Coordinator acting on behalf of the Organizer is Spacecamp spółka z ograniczoną odpowiedzialnością with its registered office in Warsaw at ul. Ząbkowska 31, 03-736 Warszawa, entered into the register of entrepreneurs of the National Court Register (KRS), kept by the District Court for the Capital City of Warsaw in Warsaw, 14th Commercial Division of the National Court Register, under the KRS number: 0000691123, NIP (Tax Identification Number): 7010710876, REGON (Statistical Identification Number): 368084457 (hereinafter the "Coordinator").
- 4. The Event's Beneficiary is Fundacja Wielka Orkiestra Świątecznej Pomocy with its seat in Warsaw at ul. Dominikańska 19C, 02-738 Warszawa, entered into the register of associations, other social and professional organizations, foundations, and independent public health care institutions of the National Court Register (KRS), kept by the District Court for the Capital City of Warsaw in Warsaw, 12th Commercial Division of the National Court Register, under the KRS number: 0000030897, NIP (Tax Identification Number): 5213003700, REGON (Statistical Identification Number): 010168068 (hereinafter the "Beneficiary").
- 5. The Event shall be held on the Social Media Platform X, formerly known as Twitter, www.twitter.com (hereinafter the "Social Media Platform").
- 6. An Event Participant is any person who owns a user account on the Social Media Platform and, on the Event's date, that is on January 28, 2024, between 12 am (00:00) and 11:59 pm (23:59) Central European Time, publishes a post on their public profile using the "#MastercardgrazWOSP" or "MastercardgrazWOSP" hashtag, shares a link to an eCollection Box that they think the Organizer should donate to and, in a creative and interesting way,

- justifies why the Organizer should donate PLN 10,000 (ten thousand zlotys) to that eCollection Box (hereinafter the "Participant").
- 7. The entity responsible for sharing data about the posts with the Organizer is Brand 24 spółka akcyjna with its registered office in Wrocław at ul. Powstańców Śląskich 9, 53-332 Wrocław, entered into the register of entrepreneurs of the National Court Register kept by the District Court for Wrocław-Fabryczna in Wrocław, 6th Commercial Division of the National Court Register, under the KRS number: 0000395367, NIP (Tax Identification Number): 5252515479, REGON (Statistical Identification Number): 144886667 (hereinafter the "Monitoring Entity").

### 2 Terms of Event Participation

- 1. The Event shall take place on January 28, 2024, between 12 am (00:00) and 11:59 pm (23:59) Central European Time.
- 2. Event Participation is voluntary. Before joining the Event, a Participant is obliged to read the Terms and Conditions.
- 3. The jury, consisting of the Organizer's and Coordinator's representatives, shall select 30 posts published on the Social Media Platform which meet the Event Participation terms stipulated in 2(4) below, in order to donate, on behalf of the Organizer, PLN 10,000 (ten thousand zlotys) to the Beneficiary. The donation will be made to 30 individual eCollection Boxes shared in the posts, totaling PLN 300,000 (three hundred thousand zlotys). Event winners shall be decided on the basis of how creative a justification provided in a post compliant herewith is.
- 4. A post compliant with the Terms and Conditions shall be understood as a post published by an owner of a Social Media Platform account on their profile during the Event. The post must contain all of the following:
  - a. the "#MastercardgrazWOSP" or "#MastercardgrazWOŚP" hashtag,
  - b. a link to an eCollection Box that the Participant wishes to submit for the Event,
  - c. a creative and interesting justification as to why PLN 10,000 (ten thousand zlotys) should be donated by the Organizer to that eCollection Box.
- 5. A single post must contain only one eCollection Box link. A single Participant may publish any number of posts.
- 6. A post must not violate the law, the rules of social coexistence, and good mores. The post must not contain racist, offensive, or vulgar content, infringe on personal interests of third parties, or violate the provisions hereof in any way whatsoever.

7. The winning eCollection Boxes shall be announced within 7 business days from the Event's end on the official @MastercardPL profile on the Social Media Platform, as well as on <a href="https://eskarbonka.wosp.org.pl/mastercardgrazwosp">https://eskarbonka.wosp.org.pl/mastercardgrazwosp</a>. On the day of the winning eCollection Boxes' announcement, the Coordinator shall make a transfer request in its bank to donate the amounts referred to in 2(3) above to the winning eCollection Boxes.

## 3 Participants' Rights and Obligations

- 1. Event Participants are obliged to follow the Event Terms and Conditions and the Social Media Platform Terms of Service.
- 2. Event Participants consent to the use of their public posts published on the Social Media Platform, containing the "#MastercardgrazWOSP" or "#MastercardgrazWOSP" hashtag, in transmissions broadcast by the Organizer in collaboration with the Monitoring Entity and the Coordinator. The transmissions shall be broadcast on January 28, 2024, on a dedicated website; for that reason, they may also appear on television or in photoreports.
